WHEREAS, the various fire companies within the Township of West Mahanoy have pointed out that practice burns for training purposes by fire companies would be violative of the open burning Ordinance; and

believe WHEREAS, the Board of Supervisors of the Township of West that it is in the Township's best interest to exempt open s of grave site preparation when the ground is frozen; and Mahanoy burning for

WHEREAS, the Board of Supervisors of the Township of West Mahanoy believe it is in the Township's best interest that open burning be permitted by fire companies when utilized for training purposes so as to insure a well-trained and qualified volunteer fire fighting system.

NOW, THEREFORE, BE IT ORDAINED by the Board of Supervisors of the Township of West Mahanoy, and it is hereby ordained by the Board of Super of the Township of West Mahanoy as follows: Board of Supervisors

- 1. That any grave digger who wishes to the Township of West Mahanoy for purposes of defrosting frozen ground in preparation of a grave site shall apply for a permit with the Borough Secretary before any open burning is permitted.
- fire chief whether That the Borough Secretary shall forward the permit request to who shall review the permit and advise the Board of Supervisors to approve same. as the
- materials which will be Each permit submitted by a grave digger shall include a burned in order to prepare the grave site. the grave list g,
- There shall be no fee accompanying the permit request.

- However, each permit must be renewed on an annual basis. A grave digger need only apply for a permit once per calendar year.
- 6. That the fire companies are permitted to utilize open burning purposes of practice and training; however, each request to utilize open burning by fire companies shall first be reviewed by the fire chief and a recommendation shall be made by the fire chief to the Board of Supervisors Board of Supervisors.
- determine on a case by case basis, upon recommendation from the fire chief as to whether to permit open burning for utilization in practice and training by the local fire The Board of Supervisors of the Township of West Mahanoy shall a case by case basis, upon recommendation from the fire chief companies.
- 8. Nothing contained herein is to be construed as permitting any person or entity exemption from previously enacted open burning Ordinances which are still in full force and effect. force and effect. as permitting any other

Effective date of this Ordinance is the 15 day of January, 1991.
