- (b) Any person who shall fail to comply with any notice or order to repair, vacate, or demolish any dangerous building, which notice is served by any person authorized to do so by the constitute a separate offense. not exceeding thirty (30) days. Each day that a violation of this ordinance continues shall of payment of the fines and costs, the person shall be subject to imprisonment for a period Board, shall, upon conviction before a District Judge, be subject to a fine not exceeding One Thousand (\$1,000.00) Dollars; and, if the person violating this ordinance is in default
- (c) Any person removing the notice provided for in Section 8 (e) shall, upon conviction before a District Justice, be subject to a fine not exceeding more than Five Hundred fifteen (15) days fines and costs, the person shall be subject to imprisonment for a period not exceeding (\$500.00) Dollars.
