PLEDGE OF ALLEGIANCE

MINUTES**

Meeting of the West Mahanoy Township Board of Supervisors was held on the above date at 7:00 p.m. Meeting was called to order by Chairman Martin.

ROLL CALL: Paul Martin, Mickey Kayes, Anthony Gladski, Atty. James Amato, Michael Michalik, Chief Marvin Livergood, Mark Pronio and Donald Zimmerman.

PUBLIC: none

Minutes of October 15, 2024, meeting was approved by Kayes, seconded by Gladski, with all three voting yes.

TREASURER REPORT: Michalik read off the report. (copy attached)

FIRE REPORT: Gladski read off report. The Altamont F.C., William Penn F.C., and the Shenandoah Heights F.C. all handed in reports for October.

POLICE REPORT: Livergood read off the report for the month of September. He reported that there were 85 calls that were handled by the police department for the month. Police stated that they issued 29 traffic citations, three criminal arrests, and had three non-traffic arrests during the month. There were also seven parking tickets issued by the department. Police collected \$369.84 for the month from parking tickets, citations, and accident reports. A total of \$13,705.16 was collected year to date.

CODE REPORT: Pronio read off report. He stated that they received a total of 51 calls during the month. The department issued two citations and sent out 39 rental registration requirement letters. Thirty-three rental registrations were paid for along with 19 occupancy permits, also \$600 was received from fines. Pronio stated that there has been a massive influx of renters among his notable issues.

ROAD REPORT: Zimmerman read off report. He stated that all Township trucks have been inspected and are ready for the winter season.

Motion to approve all reports were made by Kayes, seconded by Gladski, with all three voting yes.

CORRESPONDENCE: Chair read off letter from the Department of Labor and Industry concerning a five-year audit review of the UCC. They stated that West Mahanoy Township was in compliance with its administration of the UCC during the audit term.

OLD BUSINESS: Motion was made by Kayes, seconded by Gladski to table the motion to ~~table~~ the collective bargaining agreement between West Mahanoy Township and the United Brotherhood of Carpenters and Joiners of America Eastern Atlantic States Regional Council, Affiliate Local Union #431, with all three voting yes.

NEW BUSINESS: Chair asked for a motion to approve/ disapprove the handicapped application for 139 Weston Place. Motion was made by Kayes to approve the application, seconded by Gladski, with all three voting yes.

Chair asked for a motion to advertise Ordinance 2024-5, compensation increase for newly elected supervisors. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

Chair asked for a motion to approve the 2025 tentative Budget. Budget has been prepared and is a balanced budget with both revenues and expenditure at \$2,059,120. Included within the budget are Resolution #2024-9 and #2024-10. Township mileage will remain the same. Sewer rates will increase by \$2 per month. Motion was made by Kayes to approve the tentative budget, seconded by Gladski, with all three voting yes. Kayes also made a motion to advertise the budget for final approval at next month's meeting, seconded by Gladski, with all three voting yes.

Chair asked for a motion to approve agreement between the Borough of Shenandoah and West Mahanoy township regarding the installation of an antenna. Motion was made by Kayes to approve, seconded by Gladski, with all three voting yes.

PUBLIC: Joe Beacher, Shen. Hgts., complained about a property located at 112 Schuylkill Avenue. Pronio stated he will address it.

John Klata, Weston Place, complained about parking issues near his residence. Livergood stated that he will address the issue.

The meeting was adjourned at 7:26 p.m. Motion was made by Kayes, seconded by Gladski, with all three voting yes.
