

ORDINANCE NO. 2017-2

AN ORDINANCE OF THE TOWNSHIP OF WEST MAHANAY, SCHUYLKILL COUNTY, AND COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE, CHAPTER VII, ARTICLE 1, ADOPTED DECEMBER 11, 1947.

101. PARKING RESTRICTIONS AND SPEED LIMITS ESTABLISHED

A. Parking Prohibited in Certain Area.

1. It shall be unlawful to park any automobile, tractor, trailer, omnibus, or any other motor vehicle at any time on or along the north side or along the north curb of Schuylkill Avenue, in the Village of Shenandoah Heights, West Mahanoy Township, Schuylkill County, Pennsylvania.
2. It shall be unlawful to park any automobile, tractor, trailer, omnibus, or any other vehicle, at any time along the east curb of Swatara Road in the Village of Shenandoah Heights, West Mahanoy Township, County and State aforesaid.

3. NO PARKING ZONES- Altamont (Frackville)

Forty feet east on Oak Street starting at the intersection of Oak and Line Streets on the south side of Oak Street.

The entire length of Oak Street, north side from Spencer Street to Line Street.

No Parking Zones – Shenandoah Heights

Forty feet east on the South Side of Schuylkill Avenue starting at the intersection of Schuylkill Avenue and Swatara Road.

Forty feet west on Schuylkill Avenue, South side starting at the intersection of Schuylkill Avenue and Swatara Road.

Forty feet east on Ohio Avenue starting at the intersection of Ohio Avenue and Swatara Road.

Forty feet on Indiana Avenue starting at the intersection of Indiana Avenue and Swatara Road.

Forty feet east on Florida Avenue starting at the intersection of Florida Avenue and Swatara Road.

No Parking Zones – Shenandoah Heights (con'td)

Forty feet east on Virginia Avenue starting at the intersection of Virginia Avenue and Swatara Road.

The entire length of Schuylkill Avenue from PA Route 924 to Ringtown Road (north side)

No Parking Zones – William Penn & Lost Creek

Penna Route 54 (South side) the entire length starting a Station Marker 1/65 located North side of Route 54 in Lost Creek to Station Marker 3/00 located South side of Route 54 in Upper William Penn.

B. Speed Limit Set

1. It shall be unlawful to operate any automobile, tractor, trailer, omnibus, or any other vehicle within the business, residential areas or districts of West Mahanoy Township, Schuylkill, Pennsylvania, at a speed greater than in excess of 25 miles per hour.

2. Speed Limit Set – Shenandoah Heights

C. Violation and Penalty. Any person violating any of the provisions of this Ordinance shall upon summary conviction before any District Magistrate, be sentenced to pay a fine of \$10.00 and cost of prosecution and in default of the payment thereof, shall undergo imprisonment for not more than five days.

Speed Limit Set (con'td)

D. Severability. The provisions contained in this Ordinance are severable, and all other ordinances or section thereof, inconsistent with this Ordinance, are here by repealed insofar as they are inconsistent with this Ordinance.

104. REGULATION OF VEHICLES AS TO WEIGHT AND LOAD

A. General Provisions. Be it enacted and ordained by the Supervisors of West Mahanoy Township, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by the authority of same, that it shall be unlawful for any person, firm, or corporation, whether principal or agent, to violate or fail to comply with the following regulations pertaining to the operation of vehicles on the Township roads in West Mahanoy Township, Schuylkill County, Pennsylvania, under penalties herein provided.

B. Weight Limits. That no person shall operate any vehicles over or upon any Township road with or without a load, where the gross weight exceeds seven tons, except where such Township road intersects a State Highway (or where a truck of larger capacity is making a local delivery).

C. Violation and Penalty. Any person, firm, or corporation whether principal or agent, violating any provision of this Ordinance shall be subject to a fine or penalty of \$25.00, for the use of the Township of West Mahanoy to be collected by summary conviction before any Magistrate, as like fines and penalties are collected by lay, and in case of non-payment of fines and costs to undergo imprisonment in the County Jail for a period not exceeding ten days; provided, however, that any person convicted shall have the right of appeal as in order cases of summary offense.

D. Repealer. That all ordinance or parts of ordinances inconsistent herewith are hereby repealed.

This Ordinance shall become effective (5) five days after its enactment.
