MINUTES**

Meeting of the West Mahanoy Township Board of Supervisors was held on the above date at 7:00 p.m. Meeting was called to order by Chairman Martin.

**ROLL CALL:** Paul Martin, Mickey Kayes, Anthony Gladski, Atty. James Amato, Michael Michalik, Chief Marvin Livergood, and Donald Zimmerman.

**PUBLIC:** none

The minutes of February 18, 2025, were approved by Kayes, seconded by Gladski, with all three voting yes.

**TREASURER REPORT:** Michalik read off the report. (copy attached)

**FIRE REPORT:** Gladski read off the reports. The Shenandoah Heights F.C handed in reports for the months of January and February. William Penn Fire Company handed in a report for the month of February.

**POLICE REPORT:** Livergood read off the report for the month of February. He reported that there were 67 calls that were handled by the police department for the month. Livergood stated that they issued seven traffic citations and made no criminal arrests or non-traffic arrests during the month. They also issued five parking tickets. Police collected \$ 347.55 for the month from parking tickets, citations, and accident reports. A total of \$ \$ 948.20 was collected for fines and parking tickets for the year.

**CODE REPORT:** Martin read off report. There were 7 rental registrations, 2 occupancy permits, and 2 dumpster permits for the month.

**ROAD REPORT:** Zimmerman stated the road crew will be out tomorrow to do some cold patching for the potholes that have opened up over the last several months.

Motion to approve all of the reports were made by Kayes, seconded by Gladski, with all three voting yes.

**OLD BUSINESS:** Chair asked for a motion to advertise, if necessary, Tax Parcel 36-02-0109.000 located at 1157 West Lloyd Street for sale with a minimum bid requirement of \$3,270. Also, the property will be staked with a for-sale sign, this is to comply with the County Demolition program requirements. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

**NEW BUSINESS:** Chair asked for a motion to accept the resignation of Marvin Livergood as Police Chief. Motion was made by Kayes, seconded by Gladski, with all three voting yes. Kayes added that he hates to see him go.

Chair asked for a motion to hire Matthew Williams as a full-time police officer with a salary of \$26.63 per hour and benefits. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

Chair asked for a motion to hire John Douchette III and Jody Long as part-time police officers at a rate of \$ 20.50 per hour. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

Chair asked for a motion to go into an executive session to discuss personnel matters. Motion was made by Kayes, seconded by Gladski, with all three voting yes. Time was 7:08 p.m.

Chair asked for a motion to reconvene the meeting at 7:21 p.m. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

Chair asked for a motion to appoint Theodore Buriak as Officer-in -charge effective April 1, 2025, at a rate of \$29.16 per hour as long as he holds this position. Motion was made by Kayes, seconded by Gladski, with all three voting yes.

**PUBLIC:** Sally Koons, Shenandoah Heights, asked the Board about the noise ordinance and enforcement of this ordinance. Also, she mentioned about garbage and debris all over the property. Martin informed her to call 570-462-1991 when the issues are occurring.

Todd Trumbower, Altamont, asked the Board to install a streetlight near his residence on 105 Morea Road in Frackville. The Board discussed and stated that they will review his request and make a decision next month.

Joe Beacher, Shenandoah Heights, complained about vehicles parking opposite the flow of traffic on Schuylkill Avenue, he stated that this is illegal, and it should be enforced.

The meeting was adjourned at 7:39 p.m. Motion was made by Kayes, seconded by Gladski, with all three voting yes.
